# UPDATED - COVID-19 Guidelines - EFFECTIVE 01.06.2022

On August 26, 2021, Governor Pritzker announced that the COVID-19 Vaccine *is required for all healthcare workers, higher education personnel, and students* to slow the spread of the COVID-19 and Variant(s). In addition, masks are required indoors, regardless of vaccination status. Weekly testing is required for unvaccinated individuals. Healthcare and higher education personnel and students who do not provide proof of vaccination will be prevented from entering healthcare and educational facilities unless they follow the required testing protocol.

**NOTE**: Lakeview College of Nursing has also been informed that some of our clinical sites (long-term healthcare facility) will not accept *any* exemption(s). Another hospital clinical site will not accept a Lakeview-approved exemption. Therefore students/faculty must submit an exemption to that hospital for their review. *Please keep in mind that we may not be able to guarantee a clinical rotation if you are not fully vaccinated, which may impact your academic progression*.

#### NEW Guidance

#### VACCINATION - Required vaccination for all higher education personnel and students. Highly recommended to get a booster.

**Faculty and Students:** Faculty and students must have documented proof of full vaccination. Students must upload vaccine documentation to CastleBranch, and faculty must submit documentation to Karlee Thomen.

(Faculty/Students - Review of exemptions were already completed, and individuals were notified. Important update - please see the note above about clinical sites and exemptions.)

**Staff:** Staff must have documented proof of full vaccination. Staff must submit documentation to Karlee Thomen

### **TESTING** - Unvaccinated individuals must receive weekly testing.

Unvaccinated individuals must submit weekly testing documentation and results by each Monday at 8 a.m.

# Weekly testing may be a rapid test if <u>no</u> symptoms are present, if symptoms are present, you will need to submit a negative PCR test before returning.

# **MASKS** – All vaccinated and unvaccinated must wear a mask. Employees may remove masks in private offices.

**SOCIAL DISTANCING** -Social distance at all times when possible.

# **EXPOSURE** – Close Contact to Someone with COVID-19.

If you: Have been boosted <i>OR</i>	Wear a mask around others for 10 days
Completed the primary series of Pfizer or Moderna within the last 6 months <b>OR</b>	Test on day 5, if possible If symptoms develop, immediately quarantine
Completed the primary series of J&J vaccine within the last 2 months	until a negative test confirms symptoms are not caused by COVID-19
If you: Completed the primary series of Pfizer or Moderna vaccine over 6 months ago and are not boosted	Stay home for 5 days. After that continue to wear a mask around others for 5 additional days
<i>OR</i> Completed the primary series of J&J over 2 months	Test on day 5, if possible
ago and are not boosted <i>OR</i> Are unvaccinated	If symptoms develop, immediately quarantine until a negative test confirms symptoms are not caused by COVID-19

#### **TESTING**

All Testing Sites and guidance in Illinois: http://www.dph.illinois.gov/testing

Frequent emails are forwarded to the college community with COVID updates and include testing and vaccination information.



#### General Health & Safety

- Masks must be worn indoors by all individuals. The College will provide one cloth mask to all students, faculty, and staff. Disposable masks will be available at the front entrance(s).
- Frequent <u>hand hygiene</u> and <u>respiratory etiquette</u> should be followed.
- Continue to perform daily health screening for infectious illnesses, including COVID-19. Individuals with signs
  or symptoms of infectious illness should stay home and use a <u>COVID-19 self-checker</u> to determine whether to
  seek testing or medical care.
- Common areas (student study areas, lounges, conference rooms) will be cleaned/ disinfected regularly, and hand sanitizer will be available.
- Sanitation stations will be available in common areas (hand sanitizer, wipes, and disinfectant spray).
- High-touch surfaces such as door handles and copiers will be cleaned/disinfected regularly.
- Wide-scale absences of faculty, staff, and students will be noted and brought to the attention of the local public health department.
- Minimize outside visitors that are not on campus for College business.
- It is already a requirement for faculty and students to have up-to-date immunizations, and it is highly suggested for staff.
- Flu shots will be mandatory (unless you have received a waiver) for all students and faculty and highly recommended for staff.

#### **Instruction**

Sanitation stations will be available in all classrooms, labs, and common areas (hand sanitizer, wipes, and disinfectant spray).

#### Theory/Lecture

- Fall semester classes *will be conducted face-to-face in the classroom*, with faculty having the capability of doing sessions remotely *if needed*. (Quarantined and positive cases will be required to provide the appropriate documentation to the College.)
- Courses and classroom schedules have been slightly adjusted to create safer traffic flow and timely sanitation.
- Accommodations will be made, where possible, for vulnerable or at-risk groups and for students unable to be on campus due to COVID-19 exposure or symptoms.
- Faculty will be ready to move all aspects of courses online with synchronous learning, *if necessary*.
   Synchronous learning is remote learning in real-time; for example class is Monday 1-4, students will be online virtually simultaneously.

#### Lab and Clinicals

- Labs and Clinicals will be in-person as scheduled.
- Clinicals/Labs Compliance with health records is required. Masks are mandatory. Unvaccinated individuals will need to comply with the additional PPE requirements as a condition of their physical presence at any clinical placement facility.

Healthcare personnel and students who do not provide proof of vaccination will be prevented from entering healthcare facilities unless they follow the required testing protocol. This may impact your academic progression if the testing protocol is not followed.

**NOTE**: Lakeview College of Nursing has also been informed that some of our clinical sites will not accept *any* exemption. Another hospital clinical site will not accept a Lakeview-approved exemption. Therefore students/faculty must submit an exemption to that hospital for their review. Please keep in mind that we may not be able to guarantee a clinical rotation if you are not fully vaccinated, which may impact your academic progression.

• Students will need to stay home if they are not feeling well and will be sent home if they begin to show COVID-19 symptoms. Students must communicate with their clinical instructor and course coordinator before the absence.

We are committed to keeping our College community healthy and safe and will remain flexible as new information emerges and guidelines change, and we will respond accordingly.
